Function of the State Executive Committee:

The State Executive Committee shall be the executive body of the State Coordination Committee and shall be responsible for carrying out the decision of the State Coordination Committee.

Without prejudice to the provisions of sub-section (1) the State Executive Committee shall also perform such other functions as may be delegated to it by State Coordination Committee.

The State Executive Committee shall meet at least once in three months and shall observe such rules of procedure in regard to the transaction of business at its meetings as may be proscribed by the State Government.

The State Coordination Committee shall be bound by such directions in writing as the Central Coordination Committee or the State Government may give to it.

As per section 19(3) & u/s 22(3) the Nominated Members (other than ex-officio members) may be paid TA/DA equivalent to Grade A Officers (upon submission of bills) from their place of residence and back and a sum of Rs. 1000/- per sitting of the Committee (or its sub-committee/other works) as honorarium. The amount will be met from the head in which expenses of Disability Commissioner are being met.



Function of the State Coordination Committee :

Subject to the provisions of this Act, the function of the State Coordination Committee shall be to serve as the State Focal Point on disability matters and facilitates continuous evolution of a comprehensive policy towards solving the problem faced by persons with disabilities.

In particular and without prejudice to the generally of the foregoing function, the State Coordination Committee may within the State Performa all or any of the following functions namely: -

Review and coordinate the activities of all the Departments of Government and other Governmental and non- Governmental organisation which are dealing with matters relating to persons with disabilities.

Develop a State policy to address issued faced by persons with disabilities.

Advice the State Government on the formulation of policies programmes legislation and projects with respect to disability.

Review in consultation with the donor agencies their fixing policies from the perspective of their impact on persons with disabilities.

Take such other steps to ensure barrier free environment in public places, public utilities, schools and other institutions.

Monitor and evaluate the impact of policies and programmes designed for achieving equality and full participation of persons with disabilities.

To perform such other functions as may be prescribed by the State Government.

The State Coordination Committee shall meet at least once in every six months and shall observe such rules of procedure in regard to the transaction of business at its meetings as many prescribed.

Save as otherwise provided by under this Act, a Member of a State Coordination Committee nominated under clause (f) of sub-section 2 of section 13 shall be held office for terms of two years from the date of his nomination.
