Application for Pre-Matric Scholarship for Students belonging to the Minority Communities for the Year 2012-13.

Last date of receipt of Application 31st August, 2012.

Applications are invited from the students belonging to Minority Communities namely Muslims, Sikhs, Buddhists, Christians and Zoroastrians notified by the Central Government, pursuing education, from Class 1st to Xth, in Govt./ recognized school/institute to be awarded by the Ministry of Minority Affairs, Government of India.

Conditions for Scholarship:

- (a) To student of Indian Citizen residing in **Haryana state** only.
- (b) Maintenance allowance will be credited into the student's bank account.
- (c) The continuance of award will be subject to securing 50% marks in the previous examination. In the case of students of class 1st the income criteria only would be applicable.
- (d) A scholarship holder under this scheme will not avail of any other scholarship/stipend for pursuing the same course.
- (e) The annual income from all sources of the student's parents or guardian should not exceed Rs. 1 lakh. Inter-se selection weightage will be given to poverty.
- (f) 30% of scholarship is reserved for girl students.
- (g) Scholarship will not be given to more than two students from a family.
- (h) The student/institution should mention the details of (i) Contact No., (ii) Bank Account Number, (iii) Bank Code Number and (iv) E-mail ID, so that maintenance allowance/course fee can be deposited in his/her account.

If account No./Bank Code No. is not mentioned, the scholarship will not be sanctioned.

The eligible Candidates may apply in the prescribed form along with the requisite documents through the Head of concerned School/Institute. Head of the school/institute shall submit the application form in respect of class 1st to 8th to the District Primary Education Officer, and in respect of Class 9th and 10th to **the District Education Officer on or before 31st August, 2012.** No action will be taken on the application received after the due date.
